I, Kenny Wright, the undersigned District Attorney of said County, in the name and by the authority of the State of Oklahoma, give information that in said County of Ottawa and in the State of Oklahoma, **QUINDELL CURTIS STANLEY** did then and there unlawfully, willfully, knowingly and wrongfully commit the crime(s) of:

COUNT 1: SHOOTING WITH INTENT TO KILL ~ a FELONY, on or about the 30th day of May, 2019, by, without justifiable or excusable cause, shooting Nicole Stanley with a firearm, to-wit: a 9mm handgun, the same being a deadly weapon loaded with gunpowder and shot, held in the hands of the said defendant and which he wrongfully and intentionally pointed, aimed and fired at the said Nicole Stanley with the unlawful, wrongful, willful and felonious intent then and there on the part of said defendant to kill Nicole Stanley.

This crime is punishable by imprisonment for up to life.
